The tournament is open to dancers who:

- have a current entry in the CBD PTT (does not apply To couples/soloists/foreigners)
- will be registered by 10.03.2025
- will pay the entry fee in the amount of:
  - o for a combination in the "bronze" class and H, G PLN 60/person
  - o for style and combination in class F, E 70 PLN/person.
  - o Polish Cup, Rising Stars Polish Cup categories\*: 120 PLN/person for one program item (240 PLN per person after the deadline) per person for one program item.
  - o If you wish to receive an invoice, please inform the organizer before making the payment and send the buyer's details by e-mail,
  - o Registration for the tournament is tantamount to a declaration that the participant's health allows them to actively participate in the dance tournament, organized in accordance with the PTT regulations

\*the Rising Star category is not included in the qualifications for the Polish Championships. Only couples who did not dance in the Adults category finals (in styles, respectively) last year may participate in the Rising Stars category.

## 17. Ticket sales

Electronic payments are handled by the PayU/Przelewy24 system

The tournament organizer undertakes, in the event that the buyer pays using online payments, to deliver the purchased ticket to the buyer in electronic form to the provided email address or enable them to download the generated ticket from their website or in another form after prior contact with the Organizer. Otherwise, the Organizer will return 100% of the amount paid to the buyer within 14 days.

\* the age category is determined by the date of birth of the older partner, and in the senior categories, the date of birth of the younger partner.

23. The PTT ranking and the qualifications for the Polish Cup include the results of couples in the age categories used in the STT PTT regulations.

24. Filming of the Polish Cup

Filming is permitted for private purposes without a fee. For commercial purposes, only with the consent of the organizer.

25. Any disputes not covered by these regulations will be resolved by the Main Judge in consultation with the Tournament Manager.

26. Final provisions

- In matters not covered by these regulations, the STT regulations of the Polish Dance Society
- These regulations have been approved by the PTT Main Board.
- Third parties are strictly prohibited from conducting any business activity on the premises of the facility during the Polish Cup without the prior consent of the Organizer. The Organizer, as the lessee of the facility, is exclusively authorized to express any consent to further sublease of the space for the purposes indicated above.
- The use of graphic markings identifying the Polish Cup for professional or commercial purposes by third parties not related to the Organizer requires the prior consent of the Organizer.
